Funds will be used to ensure timely submission of mandated reports as well as participation in the development and implementation of written policies governing the CoC Board, the Coordinated Entry process, and continued implementation of the HMIS. Lastly, funds will be utilized to monitor and plan the annual Point in Time Count, use of Emergency Solutions Grant, and for the use of Community Planning and Development funds to support the CoC's efforts to address homelessness through the Consolidated Plan, Annual Action Plan, and Consolidated Annual Performance and Evaluation Report.

- 1. Monitoring Conduct monitoring on site once a year of CoC-funded projects based on analysis of performance and monthly review of expenditures.
- Technical assistance Provide technical assistance upon identification of program weakness during monitoring visits, review of expenditures, changes in program staffing, and changes or updates to HUD's goals identified in the Opening Doors.
- 3. Membership meetings Ensure monthly meetings are held, ensure members are informed with every activity and updates with regards to CoC activities.
- 4. Submission of Reports Review and submit mandated reports such as the Annual Progress Reports in a timely manner.
- 5. - 6. PIT Count Participate in the planning and implementation of the annual PIT count and monitor the timely reporting of data into the HDX.
- 7. Consolidated Planning Consult with the CoC on an annual basis to identify best use of Community Planning Development funds to address the needs of homeless persons.

3. How will the requested funds improve or maintain the CoC's ability to evaluate the outcome of CoC and ESG projects?

Planning funds will allow for the CA to focus on the development and implementation of policies and procedures that encompass the performance of the CoC as a whole, the performance of the CA as the administrator of funds, the performance of the ESG program and the various CoC-funded projects, and the performance of the HMIS. Furthermore, requested funds will improve the CoC's performance in implementing the Coordinated Entry system to ensure that households most in need of housing and/or services are prioritized for housing and appropriate services. Developing and implementing these policies and procedures will provide the CoC, the CA, and the community with a transparent process for renewing projects, developing new projects, meeting HUD's goals as stated, and identifying services and housing applicable to the homeless household's needs. GHURA planners oversees the implementation and management of ESG and CoC funded projects.
