The core of the proposed project is housing- providing a safe shelter to survivors of domestic violence experiencing homelessness. Then a Christ-centered circle of care and support services will be provided for clients to heal, thrive, and achieve stability.

Victim referrals may be received from Guam Police Department, VARO, Alee Shelter, Sanctuary, Oasis Empowerment Center, Light House Recovery Center, other organizations, and self-referrals for protective sheltering. VARO and the other organizations may provide emergency housing first using rapid rehousing funds for a minimum of three days up to three months until a vacancy occurs for shelter admission.

Domestic Violence Assessment Tools (The Danger Assessment, Adverse Childhood Experience and Resiliency Scale) will be utilized upon admission. Then, dedicated staff will coordinate services for every client including their children. Case Management and other support services will be provided through the Anchor of Hope Center for Families' programs like establishing an Individualized Care Plans (Service Plan Agreement), counseling, trauma healing and trauma informed programs, Bible Studies and prayer support, Nurturing Family Education, Life Skills Education, and Economic Empowerment Training to strengthen finances to enable long-term stability.

Other support services such as food assistance, clothing, and transportation will be provided in-kind through the various organizations inclusive of eligibility for mainstream benefits.
